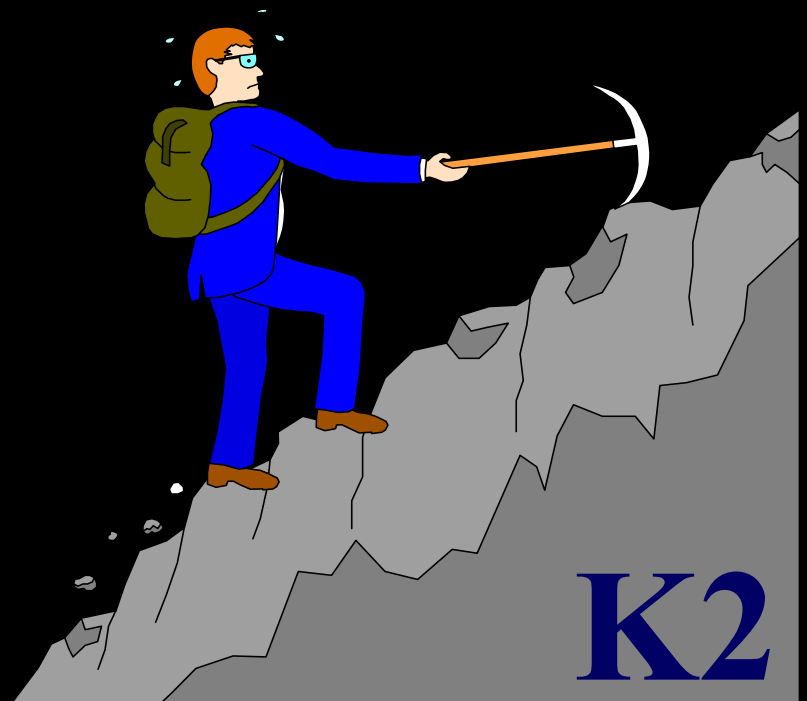
Health Insurance Portability and Accountability Act of 1996

Public Law 104-191

TITLE II, SUBTITLE F

Administrative Simplification

- 9 EDI Transactions
- Code Sets
- Identifiers
- Security / Privacy



PENALTY FOR NON-COMPLIANCE



- \$100.00 For each violation
- Maximum of \$25,000.00 penalty per year
 - Identical requirement
 - Prohibition

Litigation
Bad Press & PR !!!

Wrongful Disclosure

- Each offense
 - Fined not more than \$50,000
 - Imprisoned not more than 1 yr.
- False pretenses
 - Fined not more than \$100,000
 - Imprisoned not more than 5 yr.
- Intent to sell, transfer, or use
 - Fined not more than \$250,000
 - Imprisoned not more than 10 yr.



STANDARDS VERSUS IMPLEMENTATION GUIDES

STANDARDS

- Cross industry standards
 - Generic & Unabridged
 - No Technical Answers
 - Series of Business Questions
- Mandatory & Optional Usage

- Subsets define segments, loops, codes and sizes.

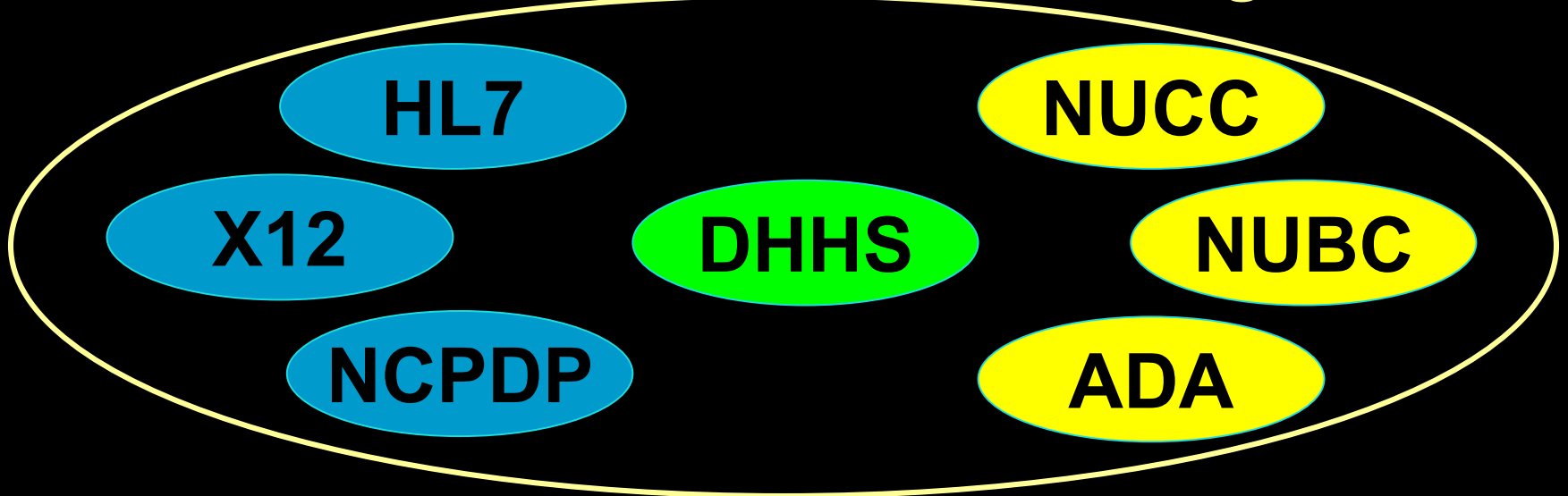

 - 278 - Healthcare Services Review –Notification
 - IHCEBI/IHCEBR - Interactive Transactions
 - Extensible Markup Language (XML) ?

 - ICD-10-CM

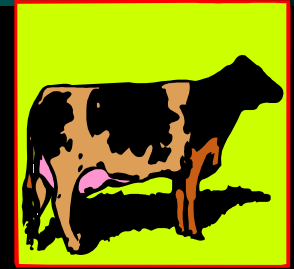

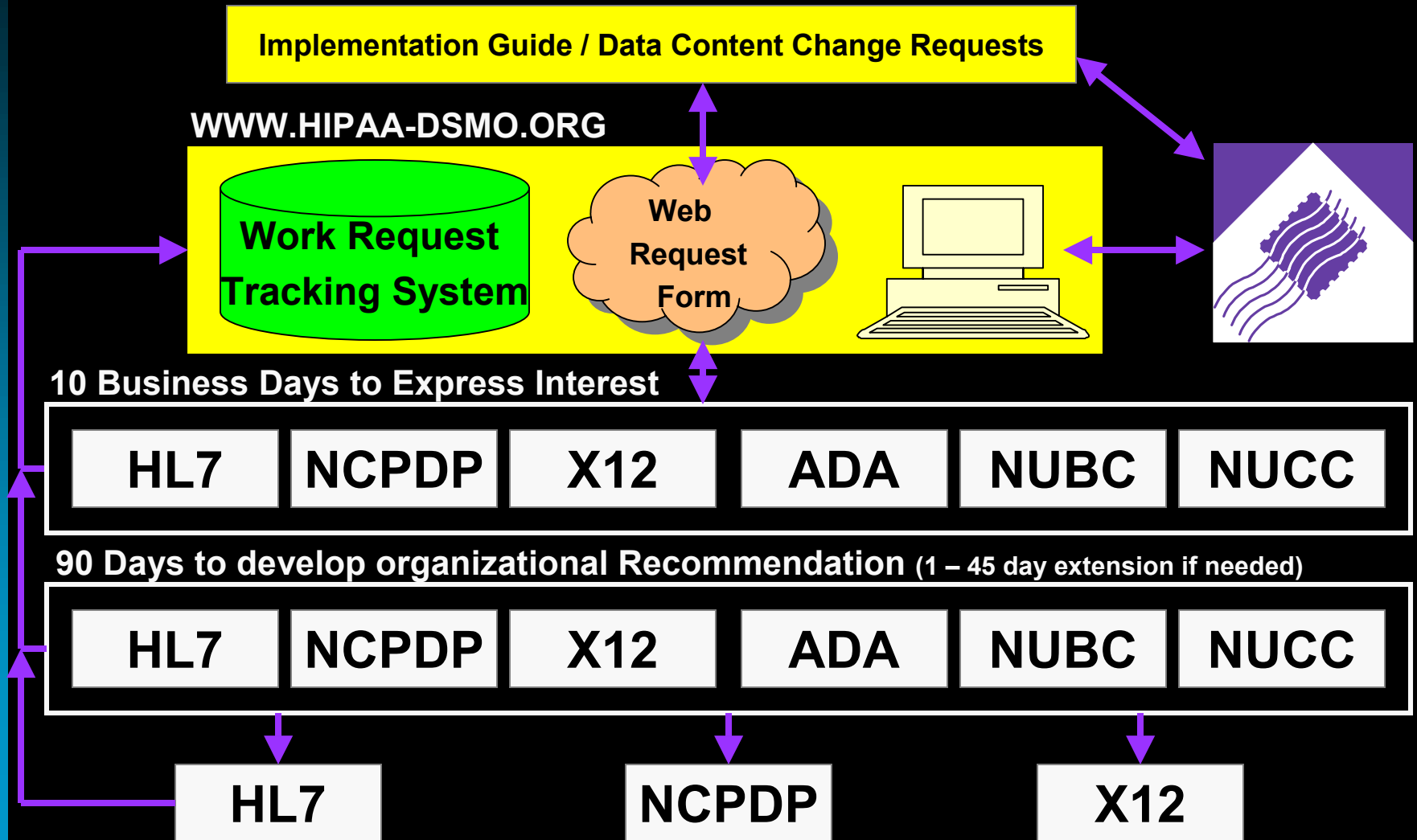




MOU Guiding Principals

- Public Access – Single Point of Entry
- Timely Review of Change Requests
- Cooperation and Communications
- Consider All Viewpoints
- Evaluate Impact of Change Requests
- Maintain a National Perspective
- Conform to Legislation

X12N Implementation Guides Changes

Three types of changes

- Editorial & Clarification
 - 4 months minimum
 - Does not change implementation
- Changes to IG but not the X12 Standards
 - 4 months minimum
 - Changes implementation
- Changes to both X12 Standards and IG
 - 1 year minimum (or more depending upon complexity)

Next Steps...

- Annually, MOU Steering Committee will provide NCVHS with a change summary & Recommendations.
- NCVHS Reviews & Provides Recommendations to HHS
- HHS
 - **Initiate the HIPAA rule modifications accordingly**
 - **Federal Rulemaking process if required**
 - NPRM
 - 60 Day Public Comment Period
 - Response to Comments
 - Publish Final Rule
 - **Include a compliance date for changes to standards**
 - **Cannot be less than 180 days**
- Version Control

EDI Resources / Education

- Skill set requirements
 - Health care knowledge
 - EDI knowledge
- Resources with both skills are very scarce
 - Recommendation
 - 1) Find people with healthcare knowledge first
 - 2) Training requirements
 - EDI Basic
 - EDI Tools
- WPC – EDI Partners
 - “Introduction to Healthcare EDI”
- WEDI / DISA / AFEHCT and others

Testing vs. Compliance Verification

- Testing (Internal & between trading partners)
 - Quality
 - Quantity
 - Business (Industry)
- Compliance Verification
 - Process to ensure that the standards are implemented in a uniform manner according to the HIPAA ANSI X12 Implementation Guidelines.

Testing - Quality

- Confirm EDI mapping
 - Application to ANSI ASC X12 transaction
 - ANSI ASC X12 transaction to application
- Assure cost effective & efficient transmission.
- Provide information for decision making.
- Validate data dictionary, utilization of code sets, and assure unambiguous data content.
- Identify change impact on prior versions/releases/sub releases.

Testing - Quantity

- Assure translation performance.
- Provide a "proof of concept" mechanism prior to deployment.
- Provide information to determine the most feasible tactical implementation plan in deployment.
- Highlight issues prior to mass deployment. Provides the capability to address these issues prior to implementation.

Testing – Business (Industry)

- Assure industry business needs are met.
- Provides an opportunity to work in concert with the various entities involved in the implementation.
- End to End or Loop testing
- Parallel processing
- Go Live!

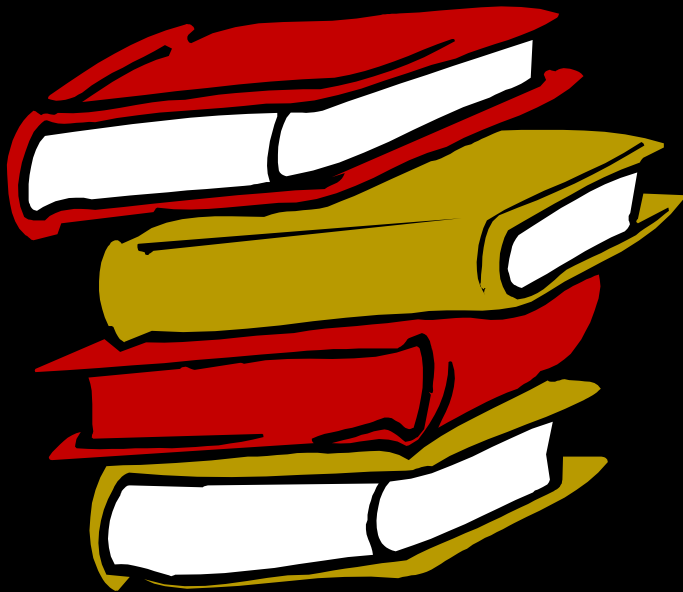
Standards Transaction Format Compliance System



Compliance Testing - STFCS

What is it?

Compliance verification and testing for electronic transactions based upon HIPAA Implementation Guides.



STFCS

Compliance Testing - STFCS

How does it work?

- Subscribers send a transaction to the secure web site for verification.
- Upon review, a digitally signed web page identifying discrepancies with the HIPAA Implementation Guide is returned.
- A log of subscribers and the transactions for which they are compliant is on the EHNAC web site.



STFCS

Compliance Testing - STFCS

How does it work? (continued)

- A successful transaction is syntactically correct and can be accepted by any trading partner.
- An EHNAC Certification Image and digital signature is issued for use with all certified transactions.
 - Certification is based on the given transaction submitted and approved at a particular date and time.
- Library of Compliant Transactions



STFCS

What STFCS Checks

STFCS checks transactions on three levels.

1. Envelope

Segments Checked:



2. Structural

- Transaction set is checked – **ST to SE**

3. Data Element

- Each data element is checked.



STFCS

STFCS – What Not Checked

- Implementation information contained in free-form notes
 - Data elements that contain specific formatting
 - X12 semantic notes

E.G. Premium Payment Guide (004010X061)

TRN03 must contain the Federal Tax ID Number preceded by a 1.

TRN03 is a situational, alphanumeric string with a fixed length of 10 characters.

STFCS will not check if the first character was a “1” but will check that there are up to 10 valid characters.

Compliance Testing - STFCS

- **What are the benefits?**

- Verifies that a company can actually send or receive HIPAA compliant transactions.
- Establishes a single objective site to provide feedback on transaction compliance
- Increases the efficiency of implementation due to reduce testing time required.
- Provides a reference library of compliant transaction for testing.



STFCS

Compliance Testing - STFCS

- **What is the costs?**

- \$595/year, which includes the registration fee and 250 tests
- An additional 100 tests can be purchased for \$100
- Annual renewal is \$395, includes 250 tests + carryover from previous year
- All EHNAC Accredited companies receive the service free of charge
