Important and Emerging HIPAA Security Areas of Concern

- Healthcare Security in Health Reform/HITECH
 - Increases in 2011 budget
 - ONC –up \$17M
 - \$2B economic stimulus still there for HIT incentives/EHR /health information exchanges
 - OCR – up \$3M for increased enforcement and outreach
 - HIT is not just for the more efficient merger of data capture and handling with clinical technology but for the more effective and safe delivery of health care

Important and Emerging HIPAA Security Areas of Concern...

- Healthcare Security in Health Reform/HITECH
 - Standards
 - HIPAA Privacy and Security
 - Conduct or review security risk analysis annually – correct deficiencies
 - Health IT Policy Committee Privacy and Security Workgroup
 - Meaningful Use
 - Various Stages
 - Implement necessary updates
 - Greater specificity
 - Encryption/decryption
 - Authentication
 - Access control
 - Transmission security for exchange and maintenance of data integrity
 - Logging for TPO

 - OCR audits
 - AGs - Is Connecticut the first of many?
 - Increased penalties
 - Incentives – OCR, patients

 - Destruction
 - Harm threshold
