The Health Insurance Portability and Accountability Act (HIPAA) was signed into law August 21, 1996

- Reduce costs
- Improve public and private health programs
- Increase electronic healthcare communication for treatment purposes
- Increase access to quality healthcare

- Expand Pre-Emption Analysis for Government Enterprise








