#### **Panel Overview**

The needs of the frail and elderly populations are widely recognized as complicated, expensive, and needing extensive coordination. ACOs in particular could benefit from implementing broader personcentered service integration across the range of acute, post-acute, palliative, and long term services and supports to reduce costs and enhance the value of care offered to their populations. Post-acute care, for example, is currently utilized by a large portion of America's population with significant growth projected over the next ten years. Due to highly variable costs across the US, it also represents a great opportunity to implement collaborative programs that would better coordinate care for patients and bring down costs. This panel will highlight the work of several leaders around the country undertaking work in these various fields, and explore the innovations and potential for creating delivery models that incorporate this broad spectrum of services.

She will tie this program into the broader clinical and financial outcomes produced by partnerships with ACOs and payers.
