## **Panel Overview**

As the conception, adoption, and implementation of alternative payment models such as ACOs and bundled payments continue to evolve and accelerate, the Office of the Inspector General (OIG) must consider different approaches to their oversight. Moreover, the recent passage of Sustainable Growth Rate (SGR) reform that calls for continued improvements in care coordination and movement away from fee-for-service (FFS) will further compel the OIG to modify their role to maintain the integrity of these programs. Panelists will draw from their experience working in and with the OIG's office to ensure compliance.

- Given the changes to payment and delivery via alternative payment models, how does OIG
  approach these new models? How does it differ from previous practices? How may it change
  moving forward?
- What are the current Issues or concerns with fraud and waste in these new programs (i.e., the role of waivers)?
