


The sub-pharmaceutical industries in China

 - Medical apparatus and instruments
 - Pharmaceutical machinery

The production scale and growth rate of pharmaceutical industries in China




The production scale of 8 subindustries in China in 2013




The drug pricing policy would be one of the main reason that slower the growth of drug sales

Production industries

- Top 10 in the world: 41.9%
- Top 10 in America:
 52.33%
- Top 10 in China:
 15.2%
- Top 100 in China:
 44.2%

Top 3 in EU: 65%

- Top 3 in China:26.7%
- Top 100 in China: 78%

- With many producers and wholesalers, small scale and lower market contribution are the main characteristics of drug industries in China
- Structure adjustment is the mainline of pharmaceutical industry development
- The implementation of GMP and GSP would further improve the quality of drug products and speed up industry restructuring.

- Further strengthening the surveillance of drug industries for keeping the drug safety and quality is still the main concern of Chinese government

- The potential factors impact the development of drug industry
 - Essential medicine policy

 - The market restructuring of distributors, especially in the rural areas

 - the impact of the change of type and amount of drug use in the public hospitals on the development of drug industry
