Expanding the Toolbox: Methods to Study and Refine Patient-Centered Medical Home Models

This series of briefs expands the toolbox of methods to help evaluators and researchers produce robust evidence that can be used to improve primary care. Nationally recognized thought leaders in research methods and PCMH models prepared briefs that describe various methods and approaches and how they might be used to study and refine PCMH models. The topics cover both "evolutionary" ways to improve evaluations—by using traditional health services research methods—and "revolutionary" approaches that draw on novel methods from other fields such as anthropology, organizational analysis, engineering, and political science. Each brief introduces a method or approach, discusses ways in which PCMH researchers have used it or could do so, and provides resources for researchers to learn more about the method.

Capacity Building: Primary Care Quality Improvement

A critical component of the PCMH is a systematic focus on quality improvement (QI) and safety; however, a broader, more explicit commitment to ongoing improvement in primary care is needed. These two companion briefs point to an effective means of assisting practices in realizing this opportunity. The first brief makes a case for building systematic, enduring, external supports for QI to assist primary care practices in the United States in achieving the triple aim of improved patient experience, improved population health, and reduced costs. The second brief describes external supports and resources instrumental in building QI capacity. Early Evidence on the PCMH

This study systematically reviews the early evidence on effectiveness of the PCMH. The interventions most often cited to support the medical home can be viewed as precursors to the medical home. The rigorous evidence indicates some favorable effects on all three triple aim outcomes, a few unfavorable effects on costs, and many inconclusive results. Although the PCMH is a promising innovation, rigorous quantitative evaluations and comprehensive implementation analyses are needed to assess effectiveness and refine the model to meet stakeholders' needs. Findings from future evaluations will help guide the substantial efforts of practices and payers to adopt the PCMH with the goal of achieving the triple aim outcomes.

This how-to guide provides information to new and existing practice facilitation (PF) programs that work with primary care practices on quality improvement activities, particularly those oriented toward primary care redesign and transformation.
