Drug Category	Best Buy Pick	Annual Savings
<b>Cholesterol-reducing</b> <b>statins</b> (to reduce LDL levels by less than 40%)	Generic lovastatin	\$1,300
Acid-reflux and heartburn treatment (PPIs-proton pump inhibitors)	Prilosec OTC	\$1,700
Arthritis pain medication (NSAIDs-non-steroidal anti- inflammatories)	Generic ibuprofen	\$1,500
Antidepressants	Three generics: fluoxetine citalopram bupropion	\$1,200

# What can you do to bring down drug costs?

Patients: Print out the reports at www.CRBestBuyDrugs.org and take them to your doctor to help open a conversation about drug effectiveness, safety, and price.

Mectical professionals: Print out the reports for your waiting room or for selected patients. Set your office computer to link to the Web site. Discuss with your patients the option of lower-cost drugs.

**Pharma distry** Make copies of the reports available to your customers, and call physicians to present cost-effective alternatives.
