Best Practices in Medicaid

- 1). Consumer directed care demonstrations
- 2). Delivering high quality, coordinated long term care to the elderly and disabled
- 3). Use of health information technology
 - -- Electronic health records, e-prescribing, electronic billing, etc
- 4). Expanding coverage through private sector initiatives
- 5). Transparent and publicly-accessible measurements of patient outcomes and/or quality improvements
- 6). Efforts to combat fraud and abuse
- 7). A link to your state webpage that includes links to your existing state plan and state plan amendments
- 8). Changes would you recommend to Title XIX so that your state could provide better services to individuals and families on Medicaid

State Solutions

Kentucky

- Legislature in 2005 created E-Health Network Board to facilitate the transition to EHRs and e-prescribing
- First state to go statewide with tailored benefits packages based on new flexibilities in Deficit Reduction Act

Indiana

 Indiana added consultations via interactive television for Medicaid patients to enhance access to care in a cost effective way.

Arizona

 2-1-1 statewide comprehensive clearinghouse for information on human services, emergency management, access to health care providers, senior services, etc
